# 2017 AAUW Minnesota State Convention Willmar

Joni and I attended the 2017 AAUW Minnesota State Convention on April 28-29 in Willmar. The convention was well attended with 25 of the 29 Minnesota branches represented. Bidding was very lively throughout the auction and our Gardening Basket sold for \$33. Joni and I, of course, each came home with a few treasures. The conversations with other branch members were as always a delight.

We started off with a backstage tour of the Barn, Willmar's local theater. John , a locally and nationally renowned wood sculptor, spoke to us about his sculpture in the lobby of the theater. This was followed by the dinner, awards and Legacy Circle Recognition. There were several Legacy Circle pins presented including one to our former member, Barb Wonson. During the remainder of the convention 4 more Legacy Circle members were recruited bringing the total in Minnesota to 16. A sing-along of patriotic songs followed the dinner.

Our Saturday started off early with meetings and training with our state board counterparts. We had questions answered and shared ideas and areas of concern with other branches. This was followed by a welcome from the deputy mayor of Willmar. Senator Amy Klobuchar sent a personal video presentation for our convention that was very well received. The keynote speaker, Kabo Yang, Executive Director, Minnesota Women's Consortium presented a very informative speech about how her personal experiences as a Hmong woman and a refugee have shaped her personally and professionally. Paul Thein, LAF plaintiff, presented the details of his case, and how the support of AAUW was critical to him and his family. The business meeting followed with only a courtesy resolution to ratify.

Joni attended the Marketing AAUW to Engage Millennials and Empowered for Leadership workshops. I attended the Funding AAUW Programs and Leaders in Action – the Willmar 8. I received great information and handouts from Dave Kirkwood, MN state board finance chair. 4 of the Willmar 8 explained the history and outcome of their struggle for equal opportunity and how it affected their lives. They are very courageous and down-to-earth women whose struggle made them internationally famous for standing up for what was right at a time when the women's movement was just starting.

Next year's convention will be held in Faribault.
