## AAUW-MN Annual Meeting May 1, 2021 by zoom

The meeting was called to order by President Mary Ann Lucas Hoax at 11:00 am.

There were about 100 people present. The changes to the bylaws, replacing "convention " with "meeting" passed. Member eligibility also passed. There were three resolutions that passed, equal pay, equal rights and Systemic Racism in Education.

The average member of AAUW-MN is 73 years old and white, not a lot of diversity.

The new officers were introduced and the outgoing officers were thanked for their participation during the year.

There was a push for donations as there was no silent auction this year.

The State Convention 2022 will be in St. Cloud on April 29 and 30. We will celebrate 100th Anniversary of AAUW-MN.

The business meeting took about 45 minutes.

The Keynote speaker was Kim Churches, CEO AAUW. She is a very enthusiastic person and many things to tell us. The is 150 years of AAUW. She talked about fellowships, items of equity first, changing the eligibility to join AAUW and a name change is not necessary as basically the letters are used. She spoke for about 35 minutes and then had questions and answers.
