Proposed Bylaws revision

The purpose of this revision is to clarify the role of the Record Keeper. The person is not required to record or take minutes of meetings. The person is required to maintain a file of all original, official minutes of meetings.

The **current** Bylaws (effective July 1, 2019), ARTICLE IX. REQUIRED POSITIONS, Section 2. Duties, e. The record keeping volunteer shall record and maintain minutes of all noticed board, membership and special meetings, and shall make the minutes available upon request for AAUW, IRS and for branch archives.

The revised section of the Bylaws (effective April 12, 2022), ARTICLE IX. REQUIRED POSITIONS, Section 2. Duties, e. The Record Keeper volunteer shall maintain the file of all original, official minutes from all membership, board of directors, committee and special meetings, and shall make the minutes available upon request for AAUW and the IRS.
